For your convenience, multiple payments can be submitted through a bulk file in the predefined file specification and uploaded directly to the site. Entries for federal tax payments can be made up to 30 days in advance and will be released to the taxing authorities up to two days prior to the payment date.

Customized to meet your needs

Based on your tax profile, only your company's specific tax codes are displayed on the screen. You can make all your tax payments in seconds and receive immediate confirmation of your transactions. No need to know complex tax code formats, just select the appropriate tax payment, enter the payment amount and the payment is ready to go. At your option, you can assign specific users to initiate payments and others to approve tax payments before release.

Access critical information

Manage information more efficiently, and track your payments with monthly or quarterly summary reports. Use the transaction history option to track past tax payments and view the history of files submitted and results of the file submission.

Easy-to-use administration allows the administrator to set up and delete users in seconds and effectively manage risk by assigning customized user profiles, access codes, account and service access, and determine what levels of information users have access to.
